If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

#### BASIC SERVICES OF THE FUNERAL DIRECTOR AND STAFF

This is the basic charge to each family we serve for our professional expertise in assisting them. It includes, but is not limited to, a proportionate share of the taxes, licenses, utilities, and business expenses necessary to serve the public in a professional manner. This fee for our basic services and overheads will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charge for direct cremation): \$300.00

\*The FTC Funeral Rule also lists that this fee is included in Immediate Burials and Forwarding or Receiving of Remains, however we do not offer those services. If these are services, you wish you may need to contact a different funeral establishment.

#### OTHER PREPARATION OF THE BODY

Minimal Preparations of unembalmed Body for Farewell Viewing \$300.00, between normal business hours which are 8:00 am to 5:00 pm, Monday through Friday  
Includes surface disinfection and setting of features, and dressing.

Refrigeration (will be an additional charge after day 10) \$50.00 per day

In accordance with Indiana Law, unembalmed human remains sheltered by the funeral home shall be placed in refrigeration after 24 hours from time of death until final disposition. Indiana law does not require embalming. However, it is the policy of

Tranquility Cremations that any non-embalmed human remains may not be viewed under any circumstance, unless such viewing is required for the purpose of positive identification. Further it is the funeral home's policy that no unembalmed body is dressed prior to placement in a casket or other burial container in clothing other than that which death occurred.) A Farewell 20-minute viewing, with a maximum of 6 individuals. These services must be planned within normal business hours which are between 8:00 am and 5:00 pm Monday through Friday.

1. Expedited service is available when requested. This charge applies if you require the cremated remains to be returned in less than 48-72 hours from receipt of the deceased and all necessary completed paperwork this is only for certain religious beliefs.
2. An oversize cremation container is required for all deceased human remains that do not comfortably fit inside a standard alternative container. If the container provided by

Tranquility Cremations is not sufficient with respect to size, the use of an oversize cremation container will be required at an additional cost to the purchaser.

3. Rates for transfer of deceased from place of death are for service within 50 miles of Tranquility Cremations. For additional mileage, add \$3.50 per mile, one way.

4. A farewell viewing consists of 1-6 individuals for 20 minutes and must be scheduled at least 48 hours in advance, with approval from Tranquility Cremation staff. Families must view from the family viewing room and will not be permitted in the crematory area. The family must sign and complete our farewell Viewing form prior to the viewing. A farewell Viewing will be arranged for one or up to six family members for the purpose of identifying the deceased. ID viewings must conclude by 4:00 pm.

5. The crematory advises that any type of identification or viewing of unembalmed human remains take place within 72 hours of death. Tranquility Cremations will not be held liable for the natural decomposition that occurs after death that may affect the appearance of a deceased individual. If an autopsy or tissue donation has occurred.
